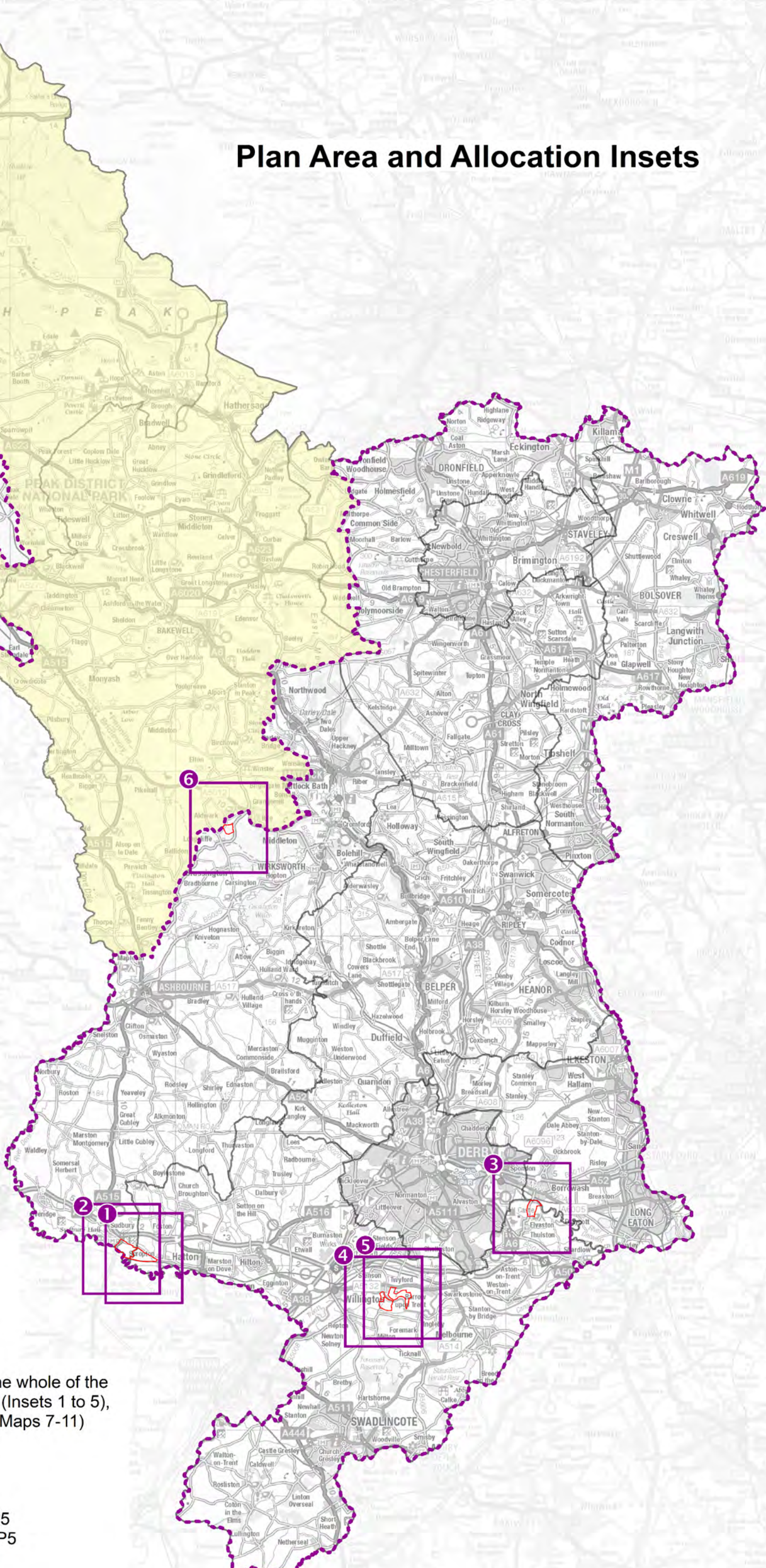

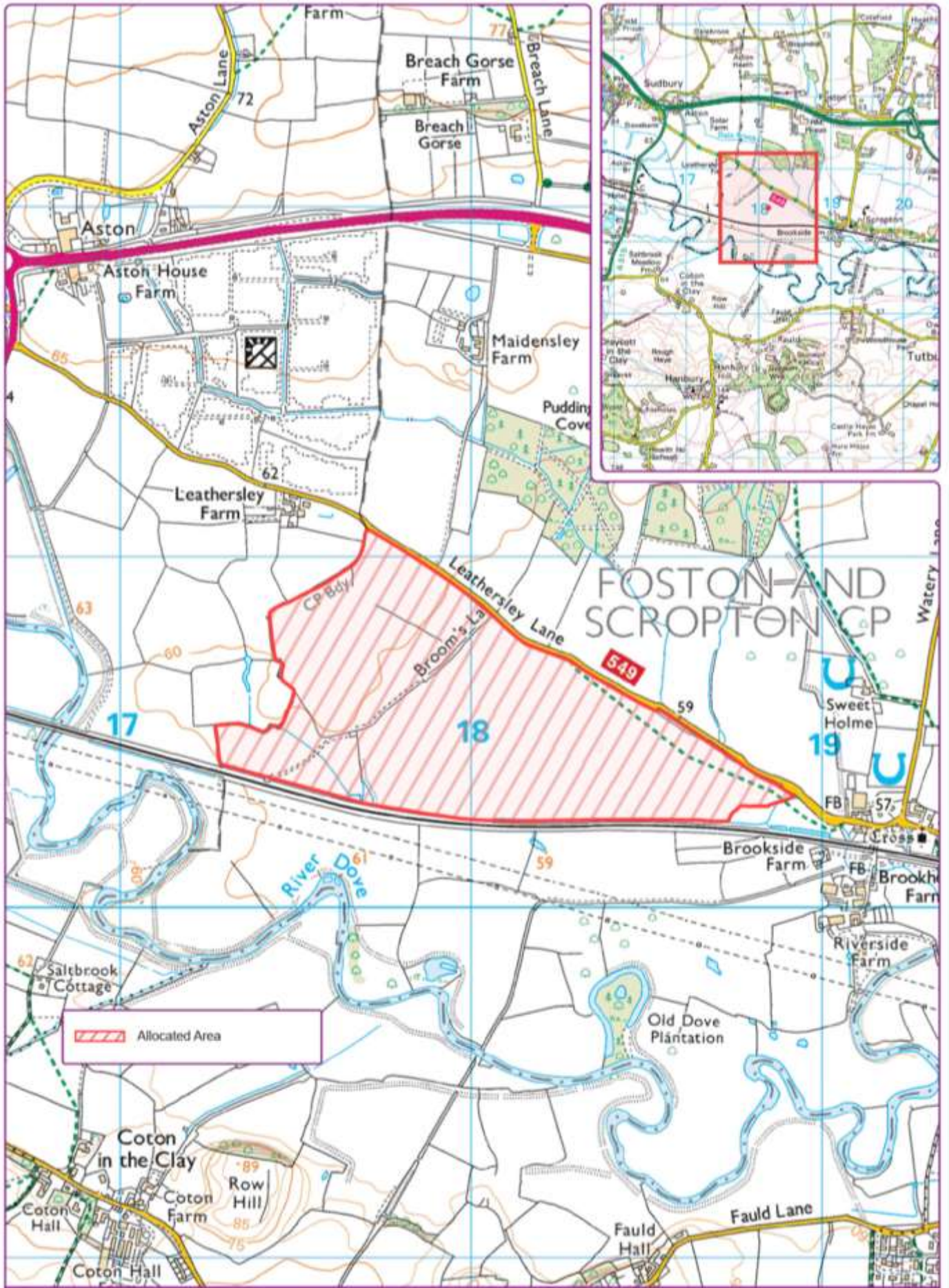

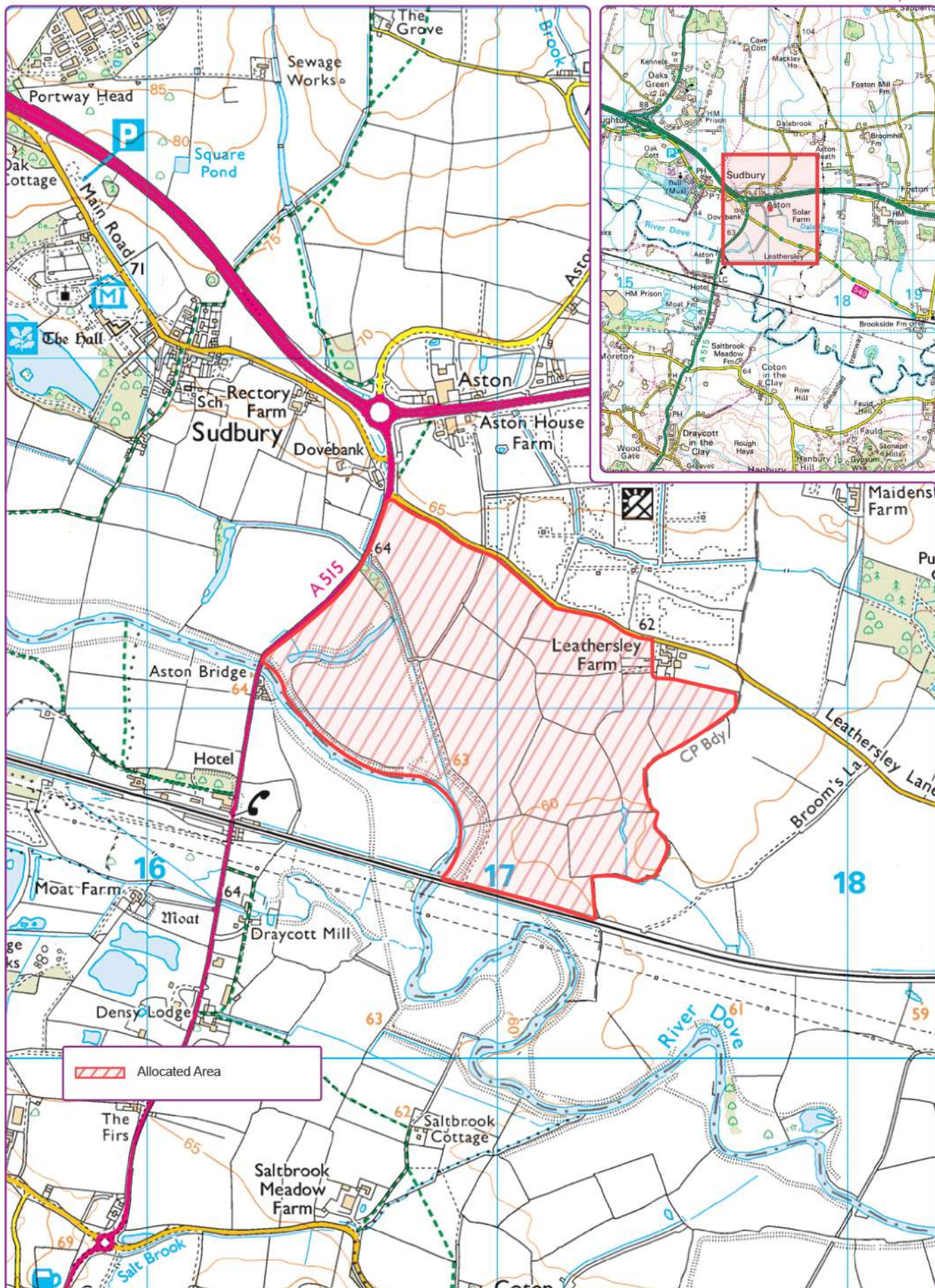

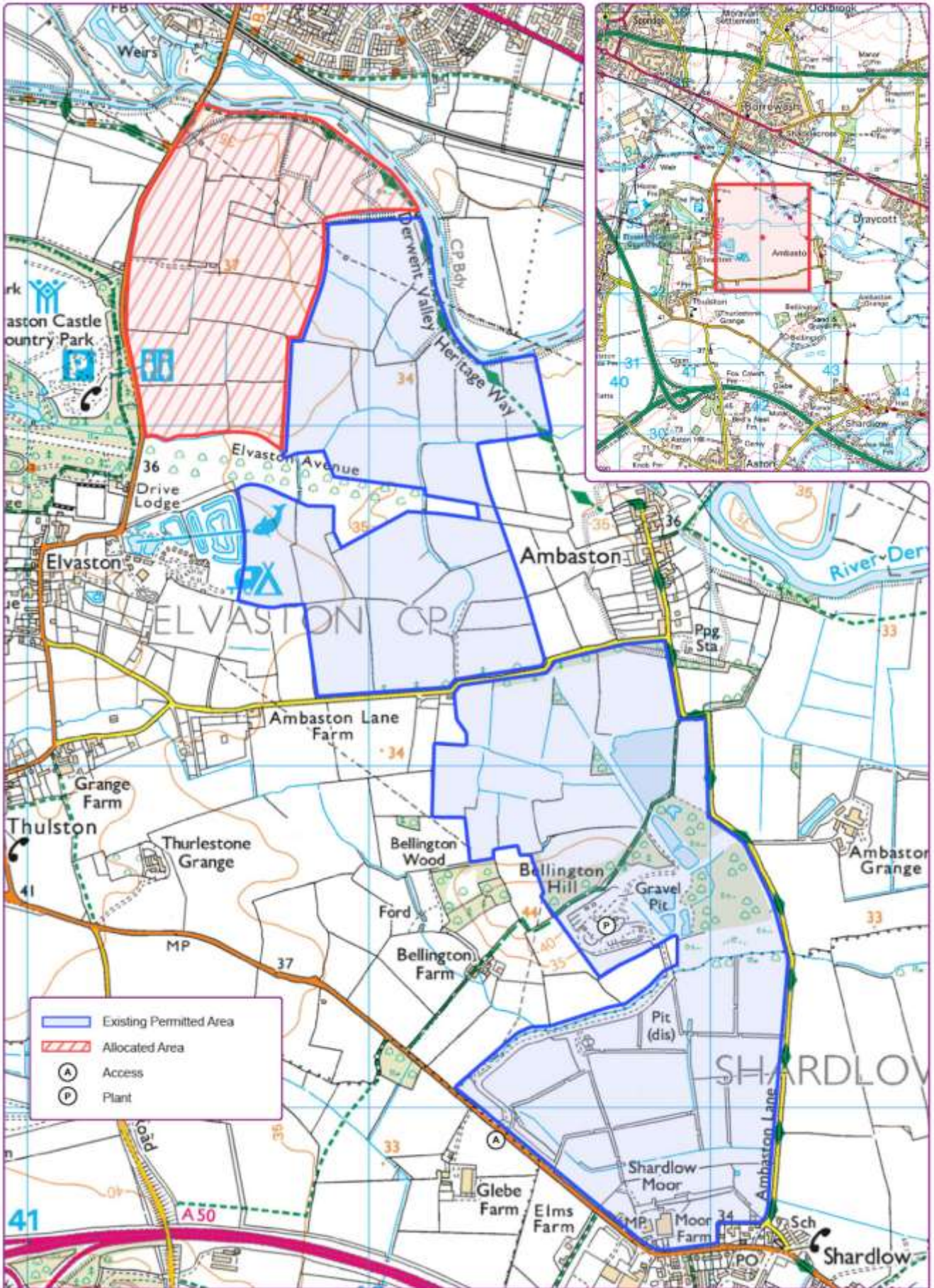

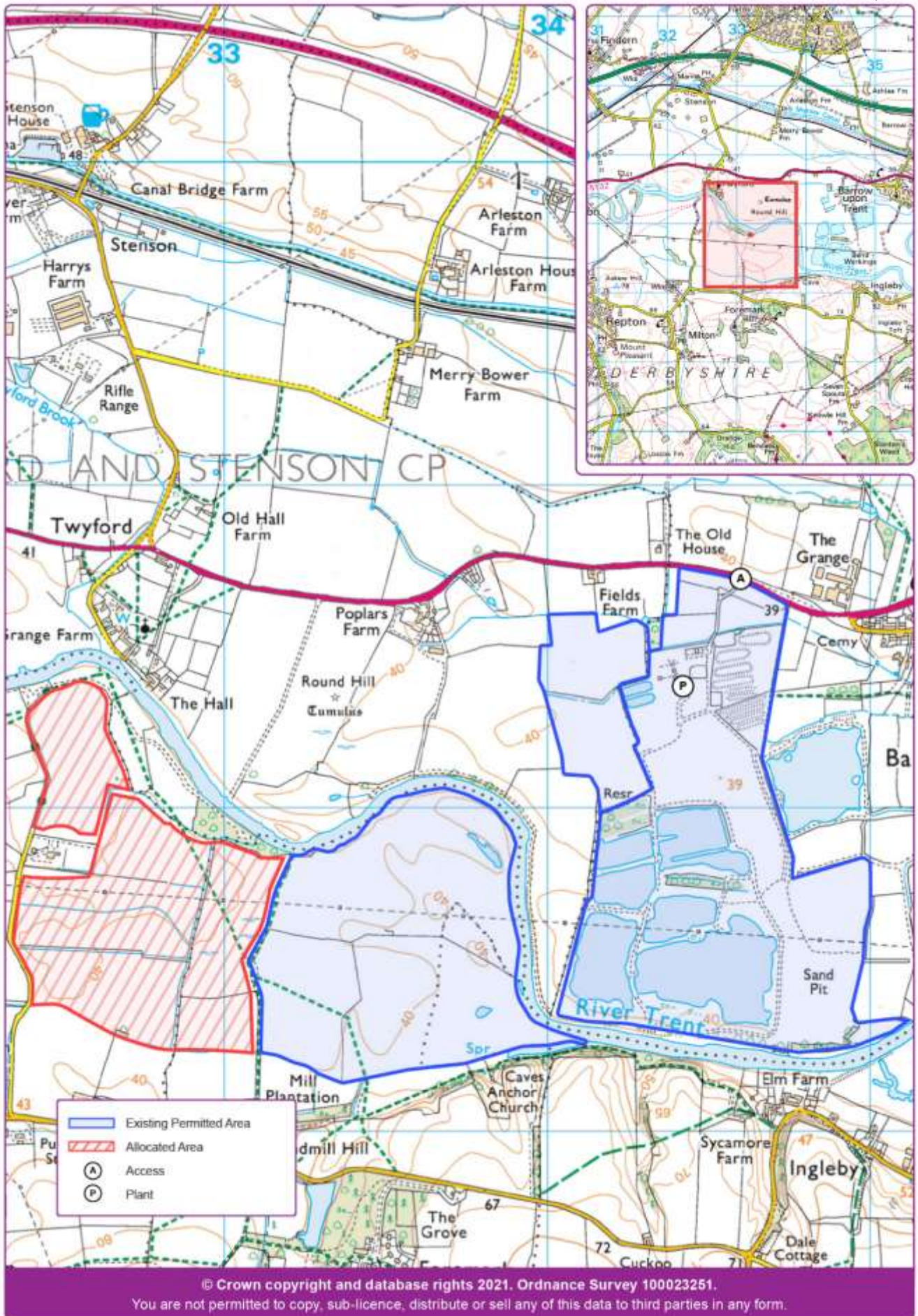

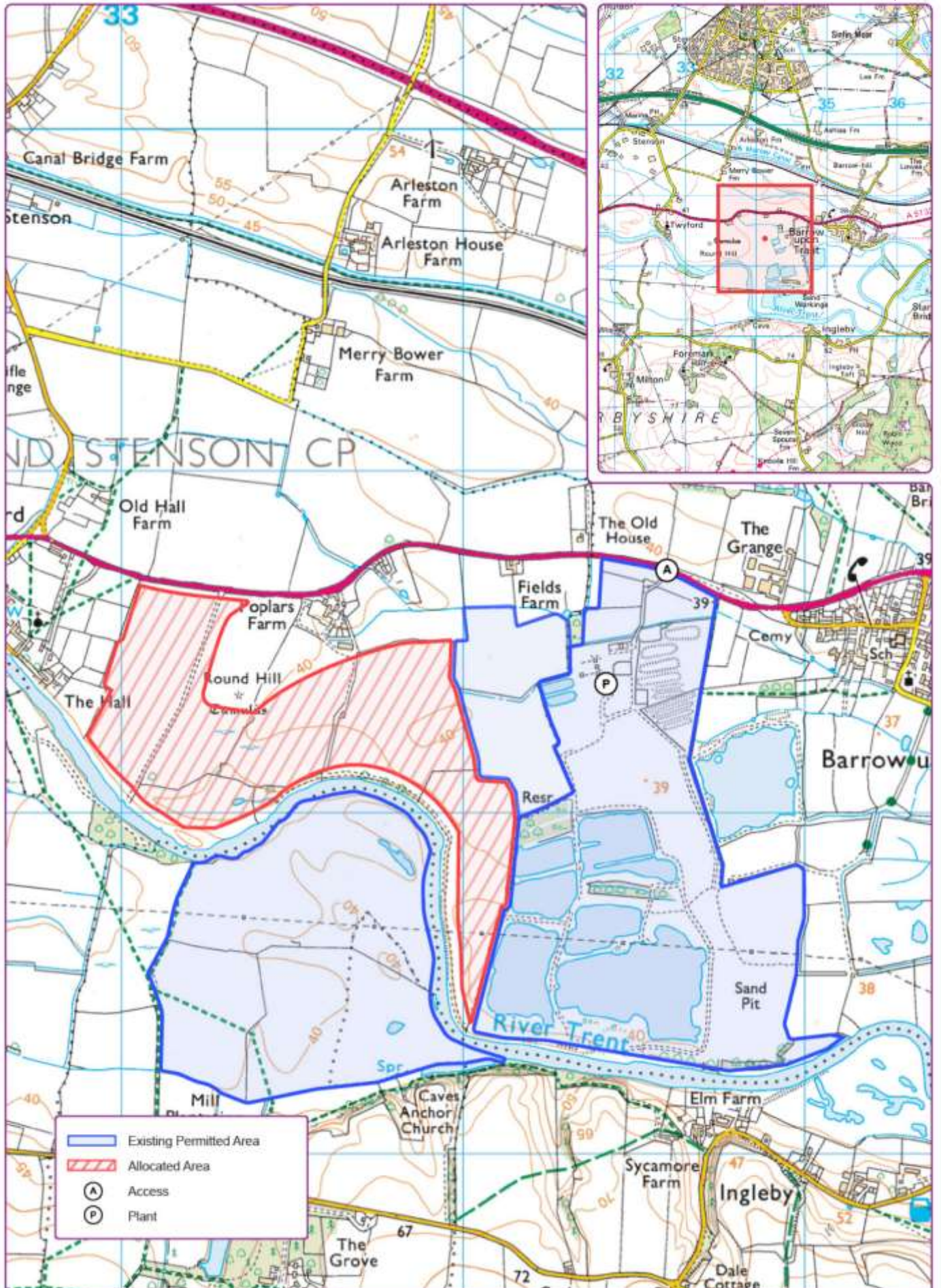
Inset 4: Swarkestone South

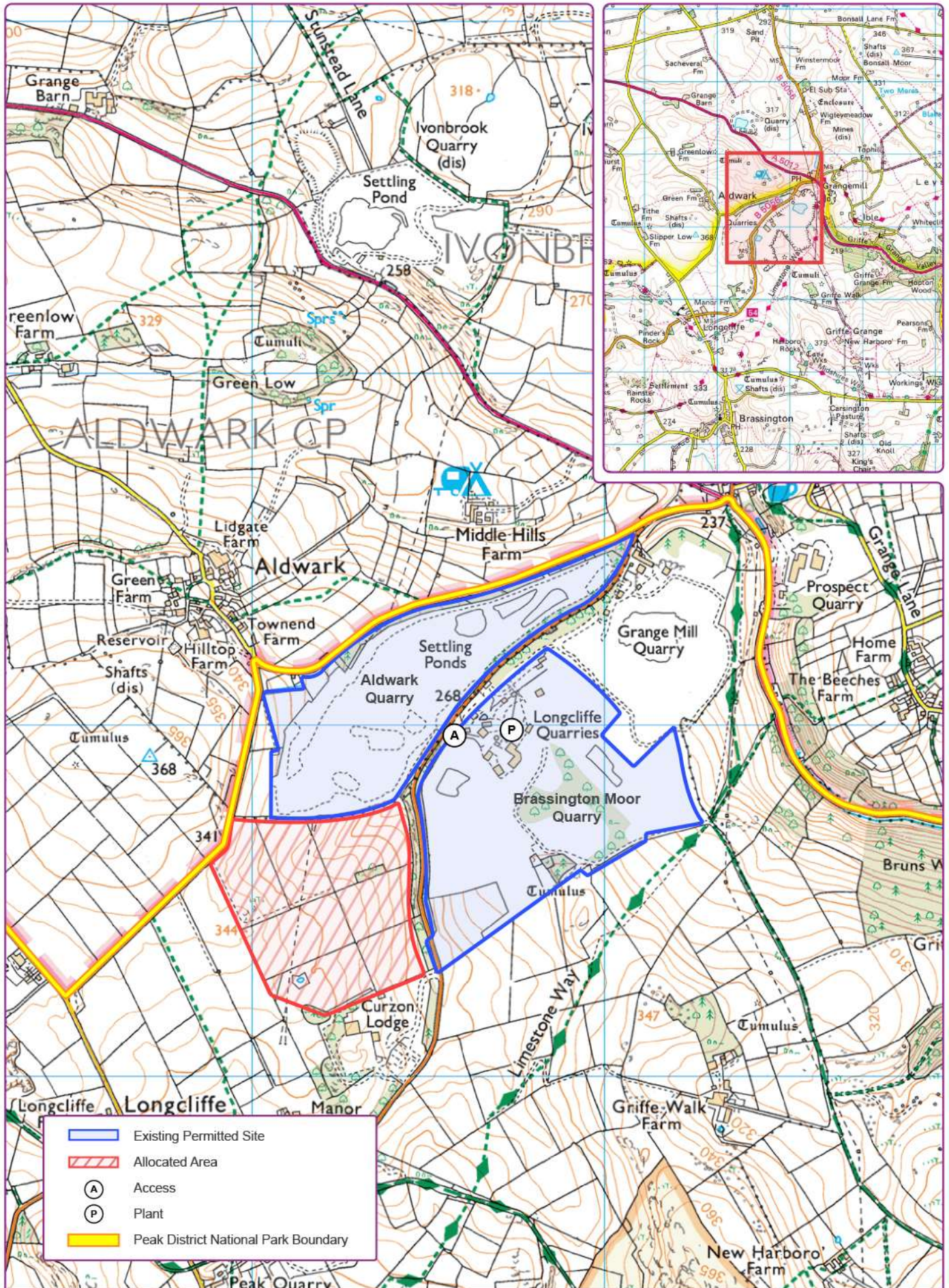

Map 7: Carboniferous Limestone Safeguarding and Consultation Areas

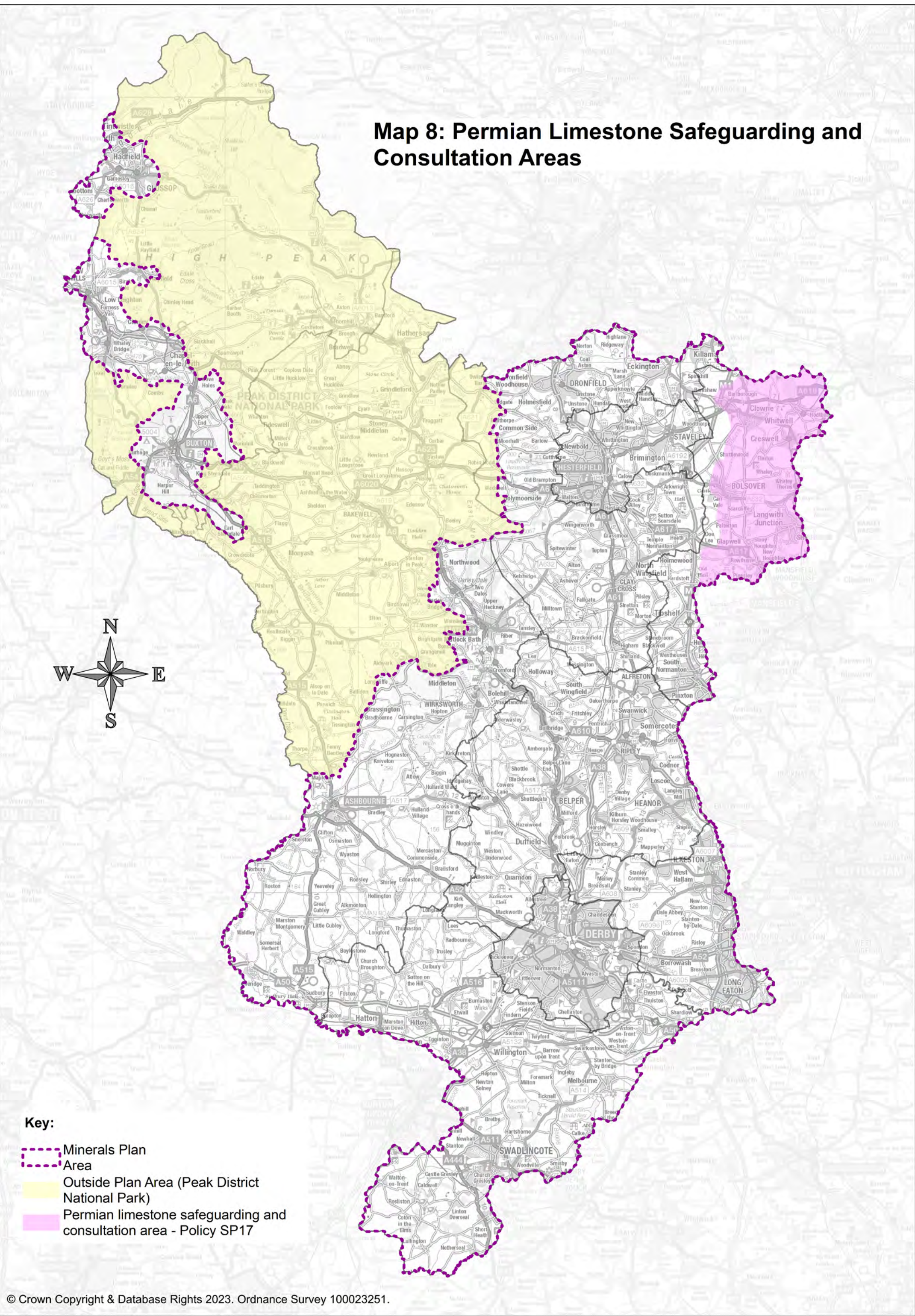

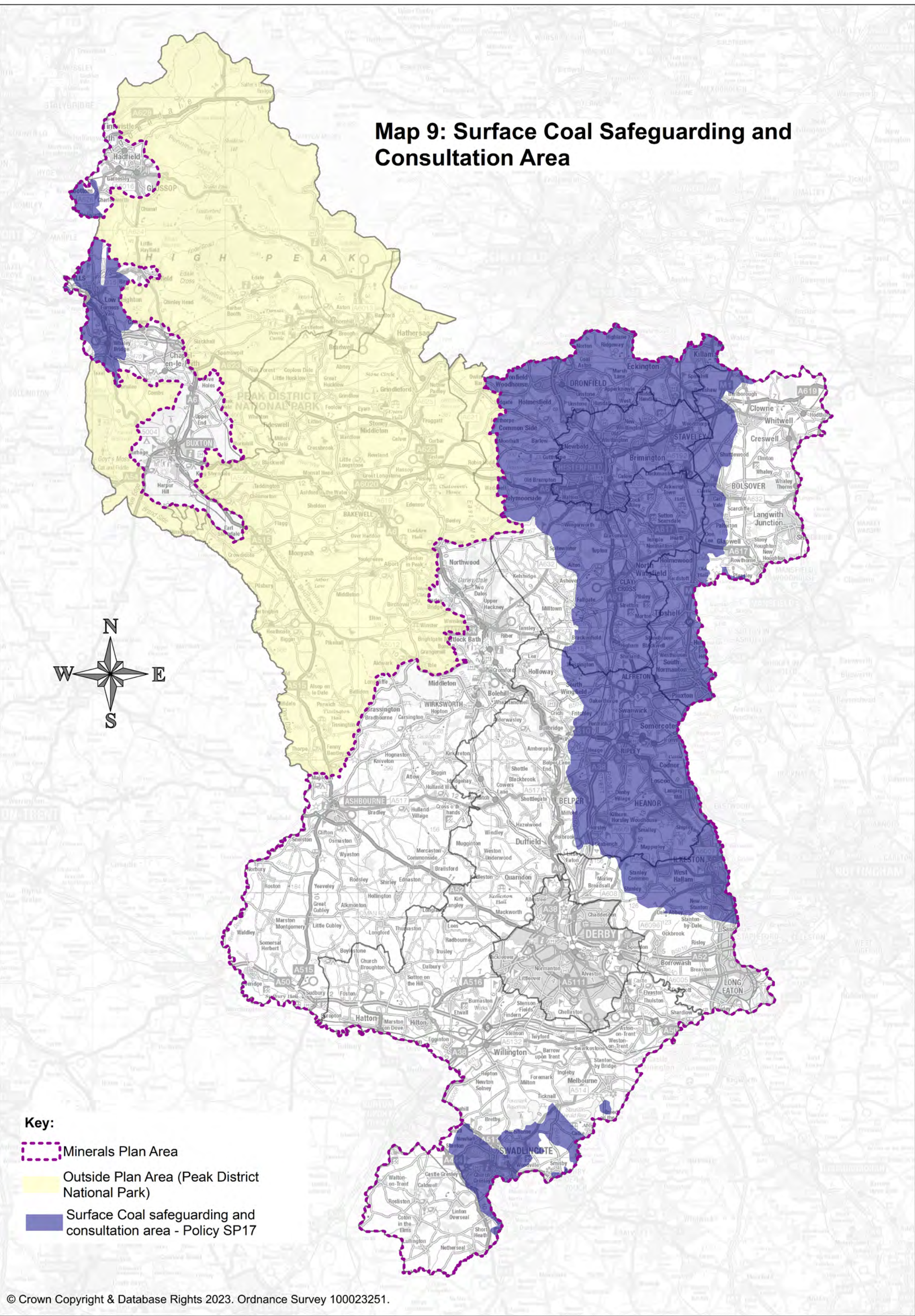
Map 8: Permian Limestone Safeguarding and Consultation Areas

Map 9: Surface Coal Safeguarding and Consultation Area

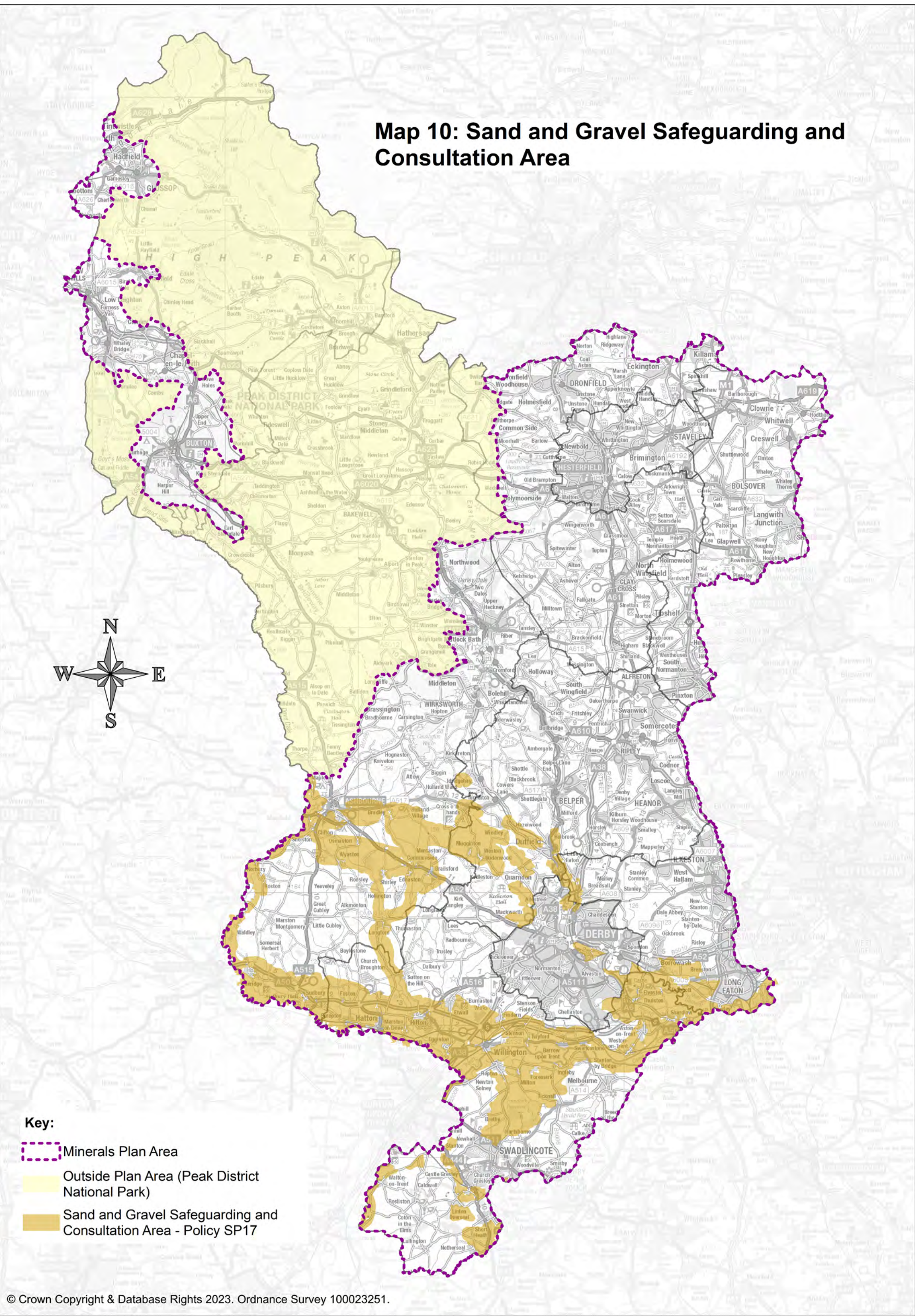

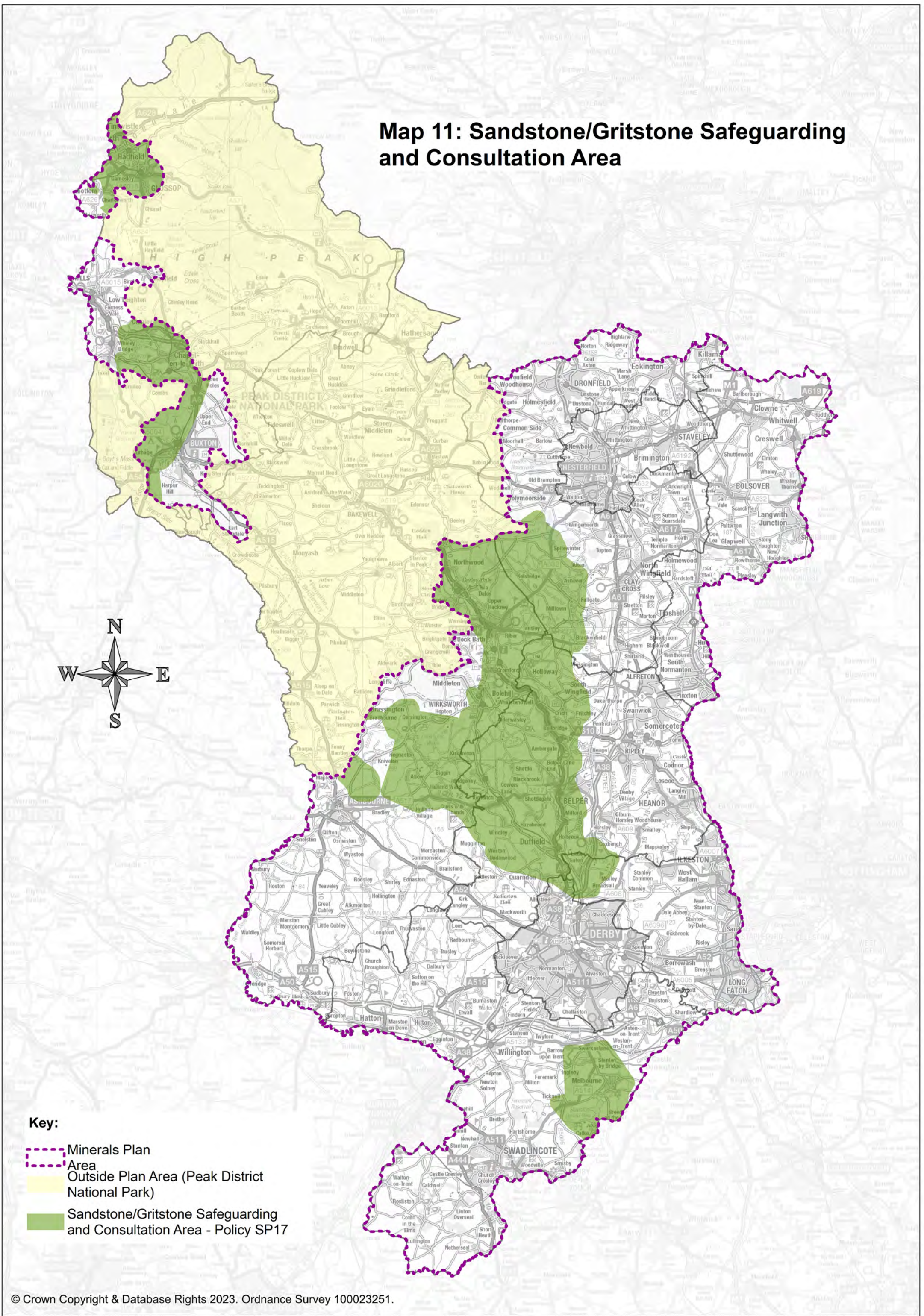
Map 10: Sand and Gravel Safeguarding and Consultation Area

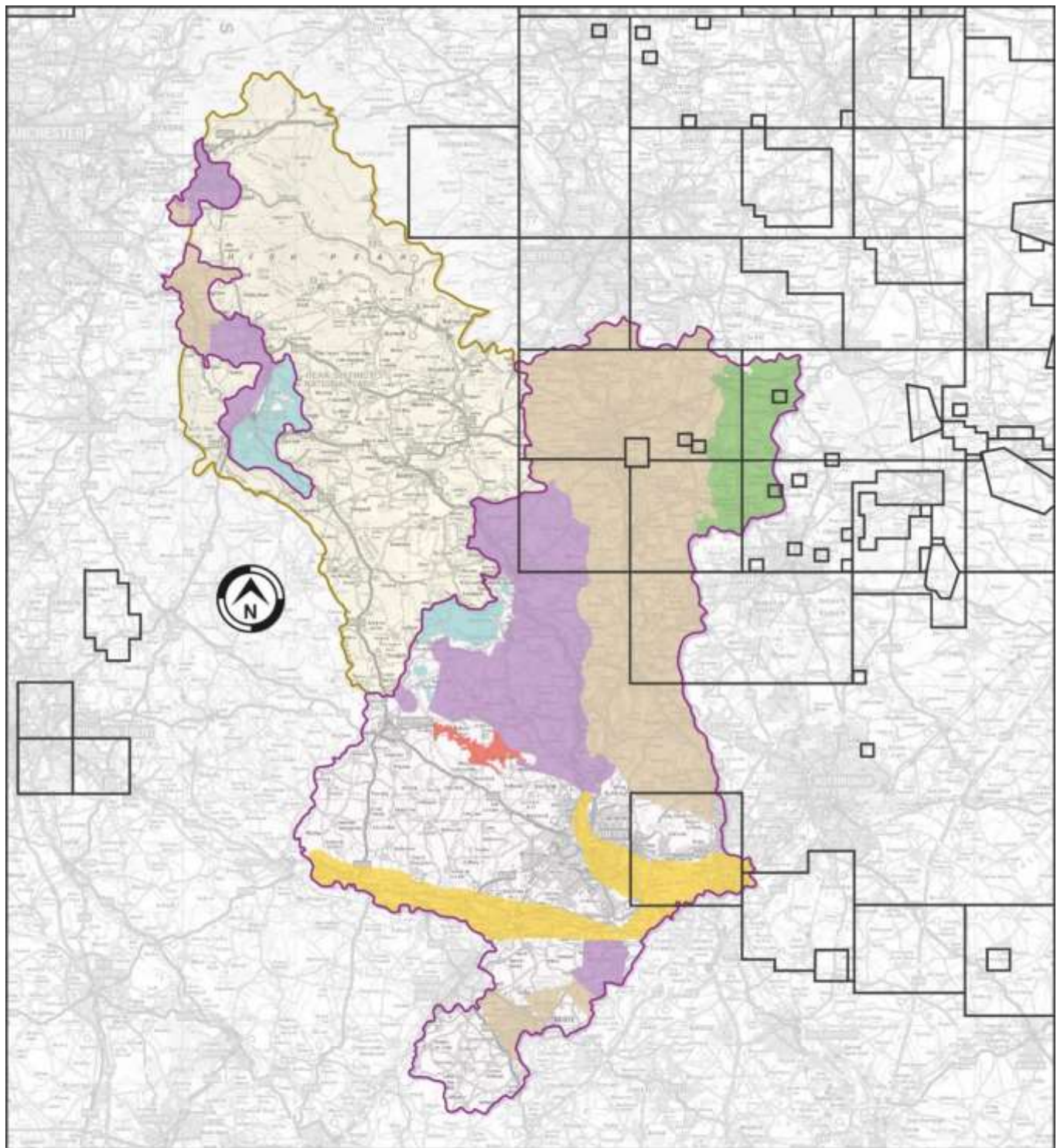











Map 11: Sandstone/Gritstone Safeguarding and Consultation Area
